Does Urban Structure Influence the Economic Development?

The paper presents empirical analysis of the interregional differences in the Russian urban system and estimates of influence of the urbanization and of the urban structure on the economic development of the territories. The analysis shows essential differences in the level of the urbanization and in the internal urban structure among the regions, but does not reveal tendency to a divergence. The estimates confirm positive influence of the urbanization and the urban diversity on the regional economic development; however the high concentration of the urban population has negative effect on the productivity. We concluded that a diversified spatial policy is more effective.

Evaluating the Effectiveness of Companies with FDI in Russia: Regional Dimension

Empiricheskaya base includes analysis Statements 31 150 companies for 2006-2013 year. The study can be said that regional policy to equalize the socio-economic situation of the subjects of inter-budgetary subsidies by a positive impact on the performance of companies with FDI in economically

weak regions. Measures to stimulate imports in the regions are also able to have a beneficial effect on the effectiveness of international and, indirectly, the Russian companies.
